What are the connotations of the choice of details? (NOTE: Details are facts or factlets. They differ from images in that they don't have a strong sensory appeal.)

Sentence structure (syntax) How structure affects the reader's attitude. What are the sentences like? Are they simple with one or two clauses? Do they have multiple phrases? Are they choppy? Flowing?
